TERMS OF SALE:

Goodyard Int'l INC PRODUCTS

TERMS OF PAYMENT: \$2,000 consignment would be only for Ready-to-wear wigs and Semi-finished wigs. All invoices are due and payable in U.S. Dollars on a C.O.D. or NET 30 basis. Denial of payment by customer's bank will incur a \$15.00 handling charge for each check returned to Goodyard Int'l INC. A service charge of 1.5 percent per month. Annual Percentage Rate of 18 percent, is assessed on all past due balances. Shipments of goods are made only to accounts in good standing. **REMEMBER: All returns are accepted for exchange only. Acceptance of this shipment is confirmation of your order.**

NO CASH REFUNDS. We maintain a liberal Exchange Policy (as outlined below).

In case of default, purchaser agrees to pay all seller's attorney and /or collection costs.

SALES TAXES: Local laws vary greatly from state to state. In those states where we are advised of our obligation to collect sales taxes, we will comply. If the customer is exempt, we must receive a copy of such evidence of exemption as will be acceptable to the taxing authority.

LIMITED WARRANTY: All of Goodyard Int'l INC merchandise is guaranteed against defective material and /or workmanship for 6 months from date of invoice. The original invoice must accompany the return. Returns not accompanied by the invoice will be sent back to the customer at their own expense. All defective products are returned for even exchange only.

EXCHANGE POLICY: Goodyard Int'l INC recognizes that our customers may need to exchange merchandise to meet patient demands. Goodyard Int'l INC provides its customers with the privilege to exchange current product within 180 days of the date of purchase. However, this only will occur if Goodyard Int'l INC receives the merchandise in re-saleable condition. All merchandise must be packages in clean bags and free labels or markings.

REMEMBER: All returns are accepted for exchange only.

Goodyard Int'l INC merchandise credit will be **AUTOMATICALLY** applied to any future purchases. No merchandise credit may be used as payment for balances due. No merchandise credit will be authorized if an account is not good credit standing. All consignment products are good for one year term. However, customer can purchase at agreed price with Goodyard Int'l INC.

It is the responsibility of the customer to ship any Merchandise INSURED to Goodyard Int'l INC. You must also send a copy of the original invoice, or a signed sales representative's authorization form. Any return not meeting these conditions will automatically be shipped back to the customer at their own expense.

CLAIMS: Any claims must be reported to Goodyard Int'l INC in writing within 15 days of invoice date.

Any damaged cartons received from carrier must be refused or reported in writing to carrier immediately at time of delivery.

Questions/ claims regarding exchanges must be made within 30 days of the date of exchange.

PRICES: All prices are subject to change without prior notification.

RIGHT TO SELL/ NO DIVERSION

Goodyard Int'l INC PRESERVES THE RIGHT TO DETERMINE TO WHOM IT WILL SELL OR CONTINUE TO SELL ITS PRODUCTS. Goodyard Int'l INC PRODUCTS MAY BE RE-SOLD ONLY TO CONSUMERS. Goodyard Int'l INC WILL NOT SELL ACCOUNTS WHO DELIVER, OR WHO PARTICIPATE IN ANY ARRANGEMENT WHICH RESULTS IN THE DIVERSION OF Goodyard Int'l INC PRODUCTS TO OTHER RETAILER, DISTRIBUTORS OR ANY OTHER SUPPLIERS. Goodyard Int'l INC FURTHER RESERVES THE RIGHT TO TAKE ALL APPROPRIATE LEGAL ACTION AGAINST ACCOUNTS WHO FAIL TO COMPLY WITH THIS NONE DIVERSION POLICY.
